The completed paper MUST include a journal of ALL/EVERY source consulted in the course of your paper research. The paper is a test of your research skills as much as a test of your exegetical and biblical-theological insights. Journal does NOT count in 20-page paper total.

There will be no final exam. Grade will be based on class attendance, participation, completion of assigned readings and (most of all) the paper.


